Is there a requirement for green spaces? Essential for community mental health Planning & Zoning has asked for citizen engagement for three

What has NENA said previously -sent letter 12/22

2-concern of the weak dimensional standards for single family dwellings 3-concern about limitations on retail/restaurants uses in R1c to corner lots only
