Asking for help from sister neighborhood associations in Boise. The effort is also co-sponsored by Open Space Association - just an announcement to let us know - petition is online BoiseParksAssociation.com Looking for volunteers to circulate petitions at Spirit of Boise and Art in the Park. If the 10K signatures are reached, the initiative will be on the 2023 November Ballet.
